Recipients of the data are authorized distributors of ZF Rescue Connect. In addition, IT service providers of ZF are involved. IT service providers are contractually obliged in accordance with the statutory data protection laws to use the data only in accordance with ZF's instructions and for the purposes of ZF in compliance with the contractual provisions. IT service providers can also be other group companies of the worldwide ZF Group, which guarantee IT support for ZF systems 24/7. ZF ensures that the data is only transferred to countries that have adequate data protection standards in accordance with the requirements of the EU Commission or, if this is not the case, the recipient has contractually entered into the EU standard contractual clauses accepted by the EU Commission with ZF, which ensure the protection of the data and the legality of the data flow in accordance with EU law requirements in this case. Further information, including a copy of the EU standard contractual clauses, can be obtained from the ZF data protection officer (contact details of the ZF data protection officer see below).

I understand that my consent is voluntary. No consequences under labour law arise from a denial.
