1. Necessary documents for the goods receipt

- Waybill
- Delivery notes
- Customs documents of third countries

2. Required pick-up documents

- Waybill, delivery notes and customs documents are generally handed over with customer goods.

3. Requirements for the equipment of the forwarder

- Loading and offloading is possible on the rear of the truck and on canvas cover trucks on the side

4. Requirements for the Forwarder

- The delivery and pick-ups has to be realized within the timeframes listed under para. 7 & 8
- Registration is in the area of incoming goods or in the office of dispatch
- Subcontractors have to announce „By order of forwarder ...“
- Goods receipt is allowed only at the unloading points, as stated in the delivery notes by the suppliers
- Pick-ups are allowed only at the loading points, as stated in the loading advices
- Cargo securing is designated by the driver
- All trucks have to carry the following equipment when entering the plant:
 - **Reflective vest** (Norm EN 471)
 - **Safety shoes** (DIN EN ISO 20345 / obsolete: DIN EN 345)
 - **Sufficient securing services material** (non-slip mat, edge protection, belt strap with validity and without damage, clean swept freight hold)

On the plant grounds drivers and passengers are obligated to wear the reflective vest and safety shoes when leaving the truck.
